

CARES Act / CRRSAA Act / HEERF Emergency Financial Aid Grants

In response to the unprecedented crisis caused by the coronavirus pandemic, the U.S. Congress passed the Coronavirus Aid, Relief, and Economic Security Act (the "CARES Act") and the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA) Act, which established and funded the Higher Education Emergency Relief Fund ("HEERF") to provide relief funding to institutions of higher education. HEERF funds are allocated to the institution with the requirement that at least 50% of the HEERF funds must be used to provide Emergency Financial Aid Grants to students to help with expenses related to the disruption of campus operations due to the coronavirus. Institutions may use up to 50% of the HEERF funds for institutional costs associated with significant changes to the delivery of instruction due to the coronavirus.

As <u>directed by the U.S. Department of Education</u> ("ED"), institutions receiving HEERF funds must publicly report the following information 30 days after receipt of funds and every 45 days thereafter:

1. An acknowledgement that the institution signed and returned the certification and agreement form and that the institution has used, or intends to use the funds to provide the mandated amount of at least 50% of the emergency financial aid grants to students.

Mayfield College acknowledges signing and returning its "Certification and Agreement" forms for student grants and institutional funding to the U.S. Department of Education. Mayfield received its allocation of the CARES Act funds for student grants on June 10, 2020, and the allocation of CARES Act funds for the institutional portion on June 15, 2020. Mayfield received its allocation of the CRRSAA Act funds on February 4, 2021.

2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.

Mayfield College has received its full HEERF allocation in the amount of \$564,629. Mayfield College received \$282,315 (P425E201607) and \$282,314 (P425F04269).

Mayfield College has received its full CRRSAA Act allocation in the amount of \$635,237 (P425Q210179).

Mayfield College has signed and returned to the Department the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.



3. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES and CRRSAA Act as of the date of submission (i.e., as of the 30-day Report and every 45 days thereafter).

Mayfield College has distributed the following grants to students (this section will be updated, as required):

As of June 3, 2020, \$58,200 has been distributed directly to students.

As of September 30, 2020, \$203,750 has been distributed directly to students.

As of December 31, 2020, \$219,350 has been distributed directly to students.

As of March 31, 2021, \$282,315 has been distributed directly to students.

As of June 30, 2021, \$370,216 has been distributed directly to students.

As of September 30, 2021, \$453,816 has been distributed directly to students.

As of December 31, 2021, \$594,216 has been distributed directly to students.

4. The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES and CRRSAA Act.

Mayfield College estimates 1,013 students were eligible to receive Emergency Financial Aid Grants.

5. The total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES and CRRSSA Act.

Mayfield College has distributed an Emergency Financial Aid Grant to 1,013 students as of December 31, 2021. (This section will be updated, as required.)

6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES and CRSSA Act.

In accordance with the CARES and CRSSA Act and guidance provided from ED, Mayfield College distributed Emergency Financial Aid Grants to as many eligible students as possible, while making available additional funds to students with more significant needs. Eligible students were offered an Emergency Financial Aid Grant in the amount between \$200 to \$360. Mayfield College determined the amount of this baseline Grant by evaluating costs likely incurred by any student impacted by the disruption of campus operations due to coronavirus, and in conjunction with the estimated number of eligible students. The amount of the baseline Grant also ensured that additional funds would be available for impacted eligible students with more significant needs caused by the disruption of campus operations.



To receive a baseline Grant of \$200, the Mayfield College student must meet the eligibility criteria as <u>detailed by ED</u> (including, but not limited to, being enrolled as of March 13, 2020 in a program that was not exclusively an online program). Mayfield College also requires the student to submit a Request Form attesting that the student incurred expenses related to the disruption of campus operations due to the coronavirus. Students were also given an additional opportunity to attest to having more significant needs caused by the disruption of campus operations. These students will be evaluated for additional Emergency Financial Aid Grants based on funds availability.

7. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.

Mayfield College notified eligible students about the availability of Emergency Financial Aid Grants via telephone calls during our daily outreach.

Eligible students submitted a Request Form to Mayfield in which the student attested to having incurred expenses related to the disruption of campus operations due to the coronavirus. Students with more significant needs were able to self-identify. The Request Form is available below.



U.S. Department of Education Student CRRSAA Act Confirmation Form

These funds are provided from the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA) Act, to be awarded as Higher Education Emergency Relief Fund (HEERF II) grants for students who were adversely affected by the pandemic.
